

Annual PCS-Contractors HSE Meeting 2022

It was the time of the year again for the Annual PCS-Contractors Health, Safety and Environment (HSE) Meeting 2022. This annual event provides a platform for PCS Management and Contractors Management to review the past health and safety performance and to realign our common goals in creating a Healthy and Safe workplace. At the same time, it was to show our appreciation to our Contractor Companies for their efforts in supporting PCS in maintaining a Healthy and Safe working environment.

However, due to the more transmissible Omicron variant of COVID-19 threatening to hit Singapore hard and fast at that time, this year's Annual PCS-Contractors HSE Meeting 2022 was held virtually on 21st January 2022 via the Zoom platform. It was the second time that this meeting had to be carried out virtually.

Despite us not being able to see each other face-to-face and have our usual pre and post-meeting chats and conversations, we were determined not to miss this opportunity to gather PCS Management, staff, and contractors together. With this meeting, we can seek common understanding and alignment of our goals, objectives, and challenges in terms of our Health, Safety and Environment performance in the Year 2022.

It was heartening, therefore, to see that our core beliefs were shared by our Contractor Companies, as representatives from the respective 28 Contractor Companies took the time to join in this annual meeting.

The meeting started with the opening address by PCS Managing Director, Mr. Hisashi Shibayama. In his speech, Mr. Shibayama commended PCS staff and contractor partners for adapting well to the COVID-19 pandemic, and the effective roll-out of the Business Continuity Plan (BCP) as well as the adopting of the Safe Management Measures (SMM). Shut Down Maintenance (SDM) 2021 was also carried out successfully and safely with the tremendous effort put in by all PCS staff and contractors working as one.

PCS General Manager (Plant) Er. Lucas Ng then delivered the keynote address, where he acknowledged the role that contractor partners and the Petrochemical Complex Contractors Association (PCCA) have played in helping to navigate through an unprecedented year of challenges in 2021, more so with 2021 being an SDM year. Er. Lucas Ng emphasised the significance of PCS on-going HSE programmes such as Behaviour Based Safety Observation (BBSO), STop and



Report (STAR), and Speak Out for Safety (SOS) being the key pillars, amongst other initiatives (e.g. Near Miss Reports), contributing to our success and our Total WSH approach for Vision Zero.

Next, Ms. Tan Peck Luan, Senior HSE Officer, presented a review of the past HSE performance for the Year 2021. Following the 2021 review, Health, Safety & Environment Manager, Er. Bernard Leong presented on the Responsible Care® and Objectives & Targets for 2022. Chairman of PCS Maintenance Contractor HSE Committee, Mr. Ivan Apostol, next presented on PCC/PCCA activities in 2021 and the WSH Action Plan for 2022. He also emphasised the importance of full participation and support from every Contractor Company, to continue to ensure



compliance and alignment of Safe Management Measures, and to achieve the targets and objectives for 2022.

PCS Safety and Health Working Committee (SWC) is mandated under the Workplace Safety and Health (WSH Committees) Regulations 2008. The members comprise of executive staff as Management Representatives and non-exempt employees as Employees' Representatives to sit in the Committee. Meetings shall only be convened when there is a quorum, which constitutes the Chairman or the Secretary and at least half or more of the total attendees must be Employees' Representatives. Meetings and inspections were conducted once a month where meetings are to discuss matters pertaining to safety, environment and occupational health whilst inspections are to highlight any unsafe acts, unsafe conditions, environmental and general HSE concerns.

In the 2021 Committee, two members, Mr Foo Suan Kim from Technology & Optimization and Mr Ong Sock Meng from Engineering exhibited remarkable dedication and commitment by voicing out safety and health concerns. It takes effort and personal sacrifices to attain perfect attendance which is one of the criteria for one to be nominated for the "Exemplary Service Award". PCS Working Towards A Low Carbon Essential Chemicals' Producer

Global warming, pollution of the environment and environmental sustainability have attracted significant global attention as scientists warn of irreversible damage to the climate and environment if drastic action is not taken promptly. Across the globe, more countries have heeded this call and are enacting legislations to limit carbon emissions and promote recycling and reduction of waste. In 2018, Singapore enacted the Carbon Pricing Act that paved the way for the introduction of Carbon Tax on 1st January 2019.

PCS, as an upstream petrochemical company, produces essential chemicals that contribute to improvements in quality of life, and serving as key materials that support various industries and people's lives. Over many years, PCS has improved its energy efficiency through cost effective projects to reduce carbon footprint. The last major improvement made was the revamping of three main compressors of No.1 Ethylene Plant in 2018.

Faced with the rapid development on the climate action front, PCS Management had organised the PCS Sustainability Team with effect from 1st February 2022 to consolidate the ongoing sustainability activities in an organised way. The main objective of the team is to spearhead initiatives working towards as a low carbon essential chemicals' producer.

PCS Sustainability Team is headed by General Manager (Plant), working in parallel with General Manager (Commercial), supported by both the Plant and Commercial Functions.

The key terms of reference are covered by all initiatives under the team, which are categorised into four categories:

Category 1: Continue activities of the existing Structured Energy Management System (EnMS) required under the Energy Conservation Act (ECA) with existing energy efficiency drive via process optimisation, operations and maintenance activities and continue exploring improvements in energy efficiency of existing facilities via Energy Efficiency Opportunity Assessment (EEOA). For instance, regular dry ice blasting cleaning for furnaces/boilers, regular seawater headers/heat exchangers back-flushing, energy efficiency improvement projects etc.

Category 3: Support Circular Economy such as green chemicals e.g. exploring feasibility to process circular naphtha derived from pyrolysis oil (from recycled plastic) etc.

Category 2: Focus on carbon abatement and carbon capture, utilisation and storage (CCUS) technologies, to achieve significant reduction in carbon footprint and carbon intensity of the existing operating facilities.

Category 4: Support solutions for renewable energy without ruling out adopting solar power and other possible innovative solutions etc.

In line with Singapore's pledge to reduce GHG emissions and target to achieve net zero emissions by or around mid-century, the team shall put in their best endeavour constantly in order to achieve significant reduction in PCS carbon footprint and carbon intensity.

Chemical Standards Exchange

- Conservation of Our Environment

The Chemical Standards Exchange is an annual flagship seminar organised by the Chemical Standards Committee (CSC) to highlight and create awareness on the importance of Singapore Standards in promoting health, safety, environment, productivity and sustainability in the chemical industry. CSC is the Standards Development Organisation at Singapore Chemical Industry Council (SDO@SCIC).

The Chemical Standards Exchange webinar for 2022 was held on 9 March 2022. The webinar was chaired by GMP, Er. Lucas Ng, who is also the Chairman for Chemical Standards Committee under individual capacity. The theme for this year focuses on the conservation of our environment (air, land and sea).

Er. Lucas Ng shared on the overview of CSC and its key initiatives during the webinar. The main objectives of CSC are to spearhead the development & facilitate implementation of chemical standards for chemical cluster & related industries in Singapore. One of the CSC's key initiatives is to look into development of standards supporting sustainability & environment aspect which covers topics such as Green House Gas (GHG) emission & carbon capture and utilisation, cleaner fuel applications such as liquefied hydrogen bulk storage & transportation and gaseous hydrogen for hydrogen fuel cells for vehicles & refuelling stations, and resource efficiency (e.g. plastic waste pyrolysis).

Mr Wang Weixiang, Director, Environmental Policy from Ministry of Sustainability and the Environment (MSE) provided the insights to the Singapore Green Plan 2030 and its relevance to our chemical industry. Singapore Green Plan 2030 is an evolving national sustainability movement, with concrete sectoral plans and targets that will position Singapore to achieve net zero emissions as soon as viable. Reducing carbon footprint, increasing our energy efficiency and saving resources are the relevant targets which promotes initiatives such as producing low carbon chemicals, using low carbon fuels, adoption of renewable energy, Jurong Island circular economy study and chemical recycling of waste. In line with Singapore Green Plan 2030 direction, PCS is constantly improving our energy efficiency, tracking our GHG emissions and has embarked on development of sustainability initiatives working towards as a low carbon essential chemicals' producer.

purview of the CSC) presented the relevant Singapore Standards for paints to reduce the urban island heat effect and support the national need to shift towards more environmentally friendly alternatives. In line with "SS 678:2021 Specification for solar reflective water-based coatings", a new type of heat-reflective paint is to be used for some Housing Board blocks to absorb less heat during the day and thus emitting less heat at night leading to a cooler environment.

Members from the Working Group for Oil Spill Dispersants (under Technical Committee for Chemicals and Processes), Ms Lau Siau Li and Ms Joanne Francia Solis, shared on the importance of dispersions in mitigating oil spills to allow the continuity of marine. A new Singapore Standard on oil spill dispersants will be developed to specify the requirements for oil spill dispersants that can be used in Singapore waters to combat oil pollution incidents, and to provide oil spill responders with technical information on the usage of dispersants for combating oil spills.

Mr Wendell Harms, a member from the Working Group in reviewing "SS 603:2014 Code of Practice for Hazardous Waste Management" shared the insights on how to manage hazardous waste responsibly. Circular economy / resource recycling is one of the areas for review in line with Singapore Green Plan 2030.

The webinar ended with a panel discussion moderated by Er. Lucas Ng. Active participation from participants and insightful inputs from panellists during the session had ensured that the webinar stayed relevant and engaging to the participants.

This Chemical Standards Exchange successfully provided guidelines and created awareness among the participants on the current/future Singapore Standards supporting conservation of our environment and sustainability. Let's await the next informative Chemical Standards Exchange in 2023!

COVID-19 has affected all aspects of our life with the world going towards VUCA environment (Volatility, Uncertainty, Complexity, and Ambiguity). Since March 2020, travelling overseas was restricted with the closure of international borders. With the introduction of Vaccinated Travel Lane (VTL) by Immigration Checkpoint Authority (ICA) in December 2021 which allows overseas travel, it is now possible to meet family members after more than 22 months.

I travelled to Kolkata, India for “Home Leave” in January 2022 with VTL option and followed all protocols as per ICA and Indian Immigration for both International and Domestic flights. This is a “New Normal” experience for overseas travelling – a new experience after 26 years of my international flying. My notes talk about the protocols which I followed to ensure that I remain safe and sound as well as abide by all the rules laid down.




